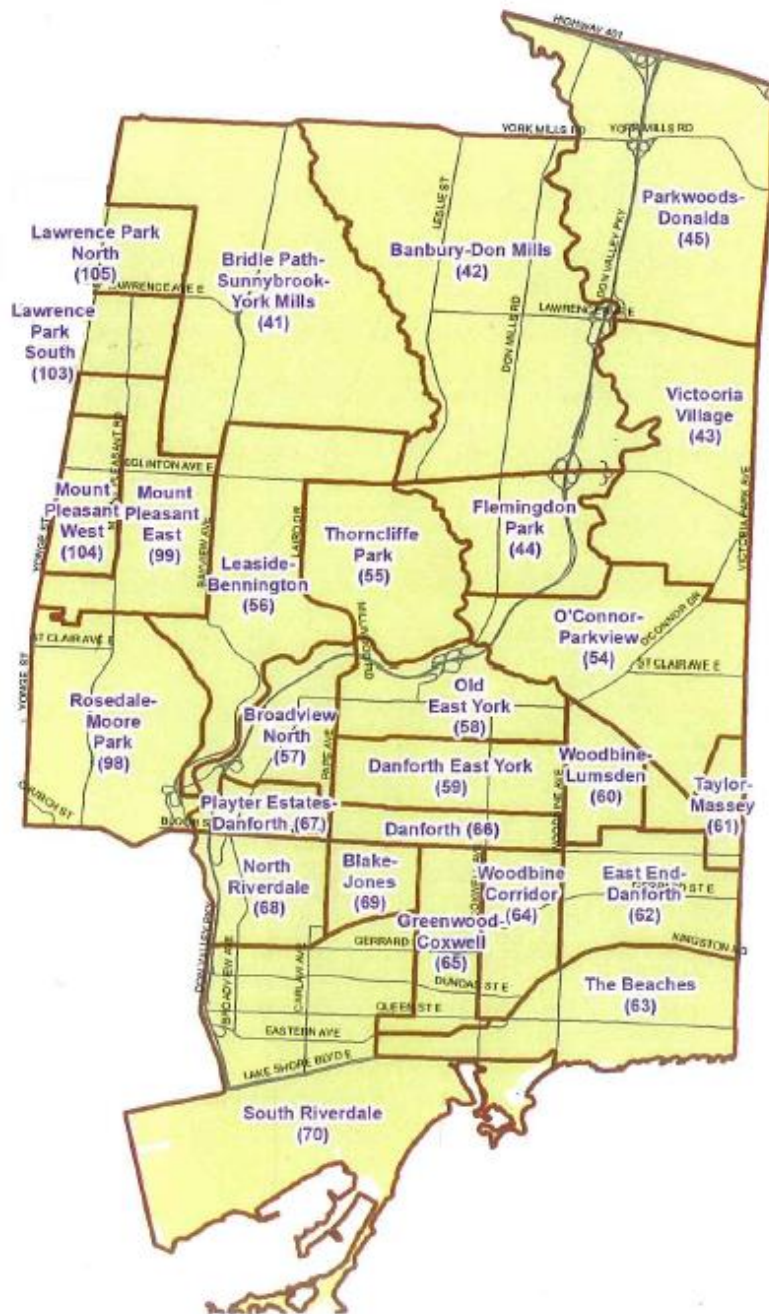

Tenants Have Rights

The Residential Tenancies Act (RTA) is an Ontario law that gives landlords and tenants specific rights and responsibilities.



Responsibilities of Tenants

Pay Rent in Full & On Time

Ordinary Cleanliness

Repair of Undue Damage

Changing Locks

Not to Harass, Obstruct, Coerce,
Threaten or Interfere





Responsibilities of Landlords

Repairs and Maintenance

Not to Interfere with Reasonable
Enjoyment

Changing Locks

Not to Harass, Obstruct, Coerce,
Threaten or Interfere

Privacy

Your landlord is not allowed to harass you, threaten you, or invade your privacy.

Your landlord must give you notice in writing 24 hours ahead of time if they need to enter your unit. They can come in only for a valid reason and only between 8 a.m. and 8 p.m.

Exceptions:

- Tenant Consents
- Emergencies
- To show unit to prospective tenants if you are moving (must be between 8 a.m. and 8 p.m.)

Responsibilities of Landlords

Supply of Vital Services

Vital services include fuel, hydro, gas, hot and cold water.

Rent Increases

When is my landlord allowed to increase the rent?

Landlords are allowed to raise the rent by a guideline amount once per year.

The annual rent increase guideline amount is set by the Ontario Government every year. For 2023 the guideline is 2.5%.

Landlords must provide tenants with written notice of a rent increase at least 90 days before it takes effect.

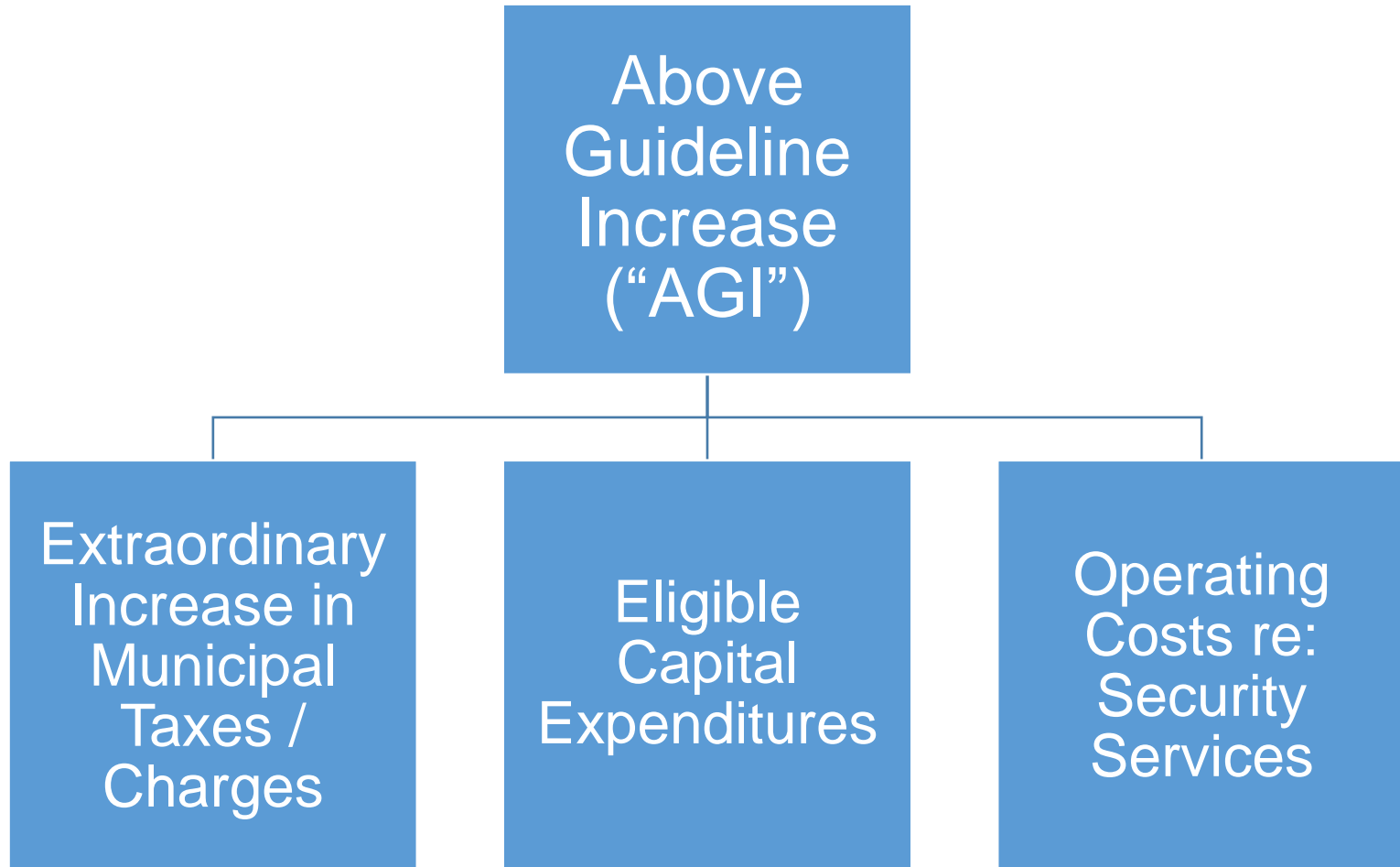

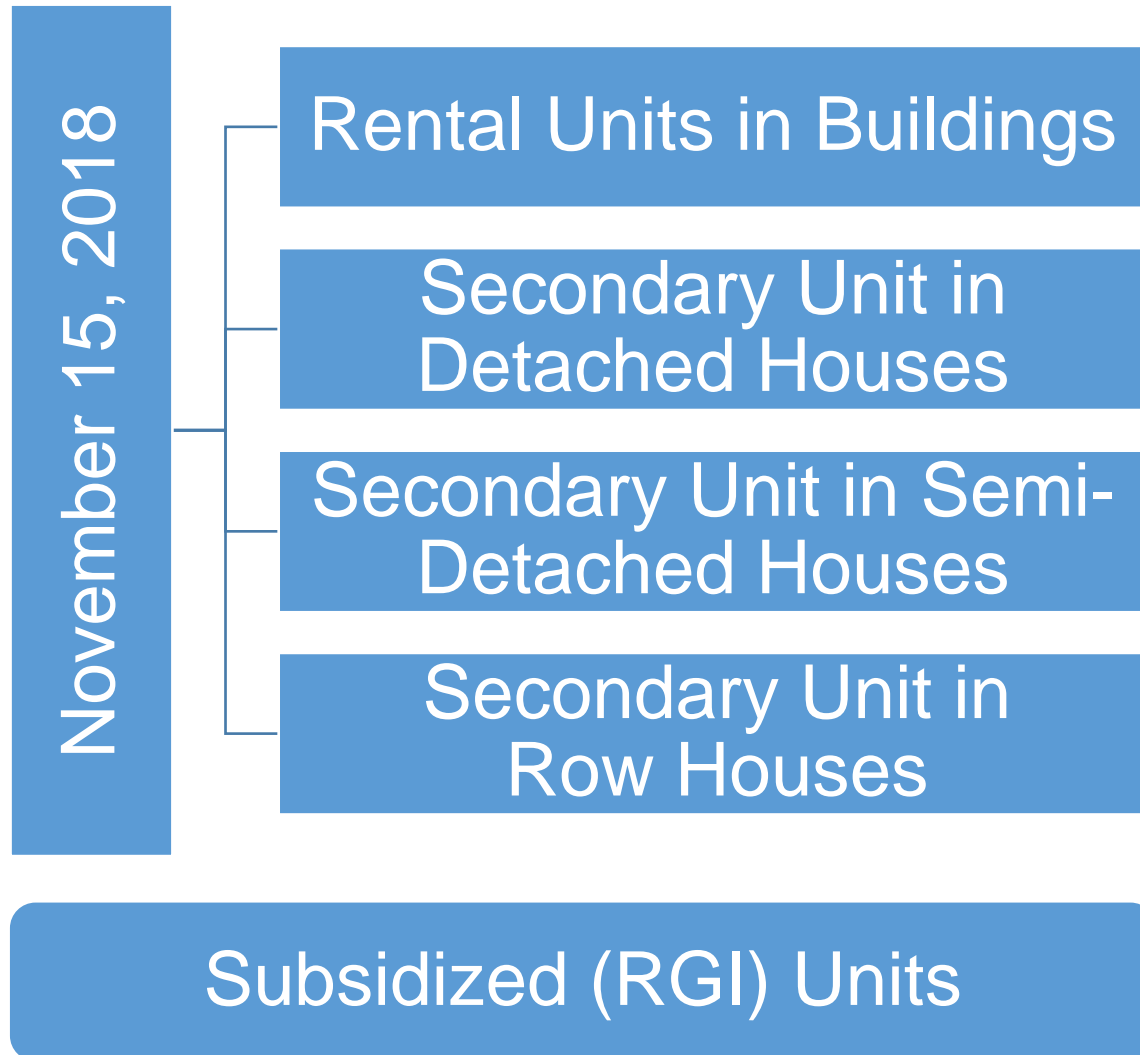

- 1.8% (2019)

- 1.6% (2015)
- 0.8% (2014)
- 2.5% (2013)

Above Guideline Increase

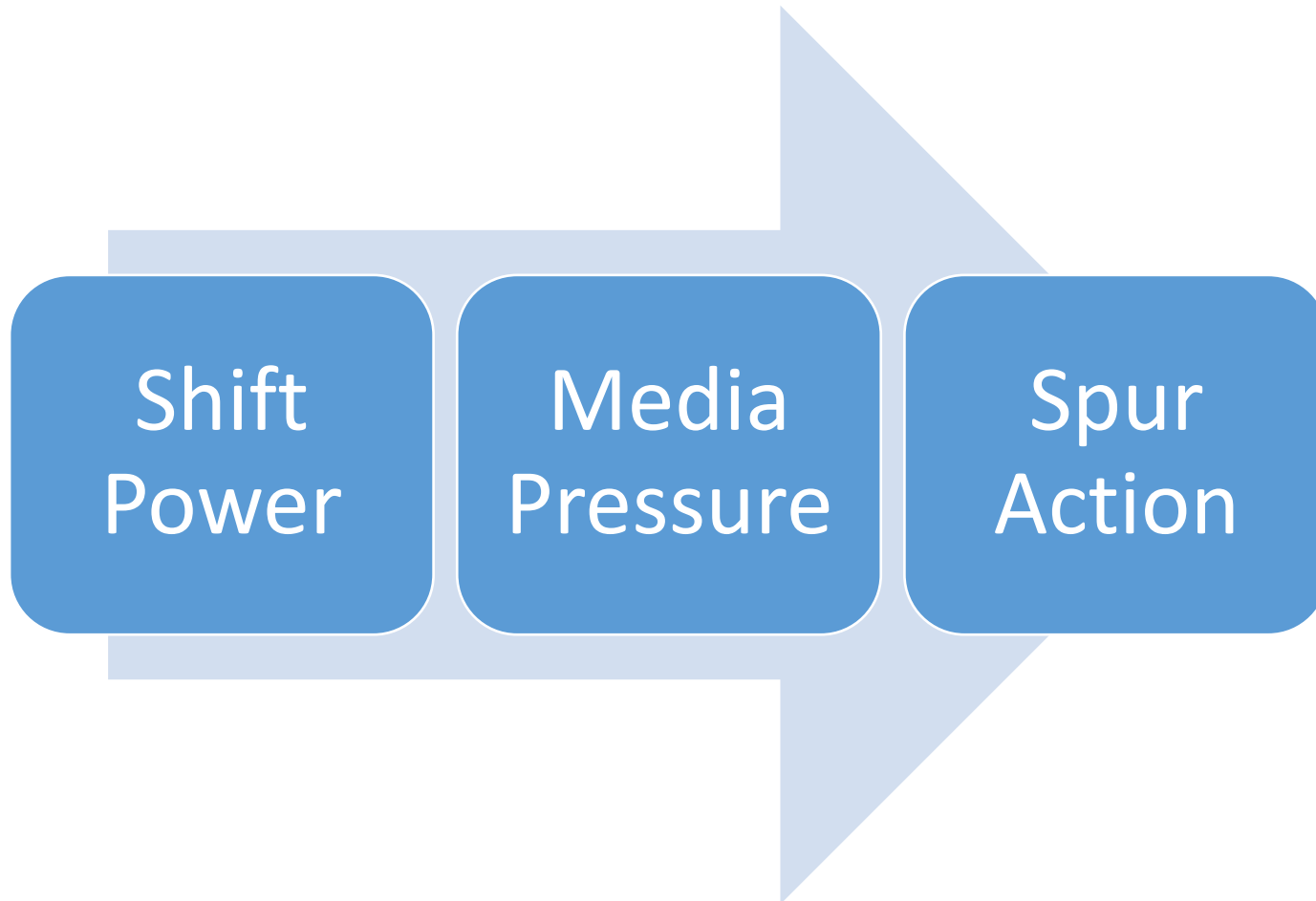
If your landlord wants to increase the rent above the guideline, they must follow the legal process and give you proper notice.



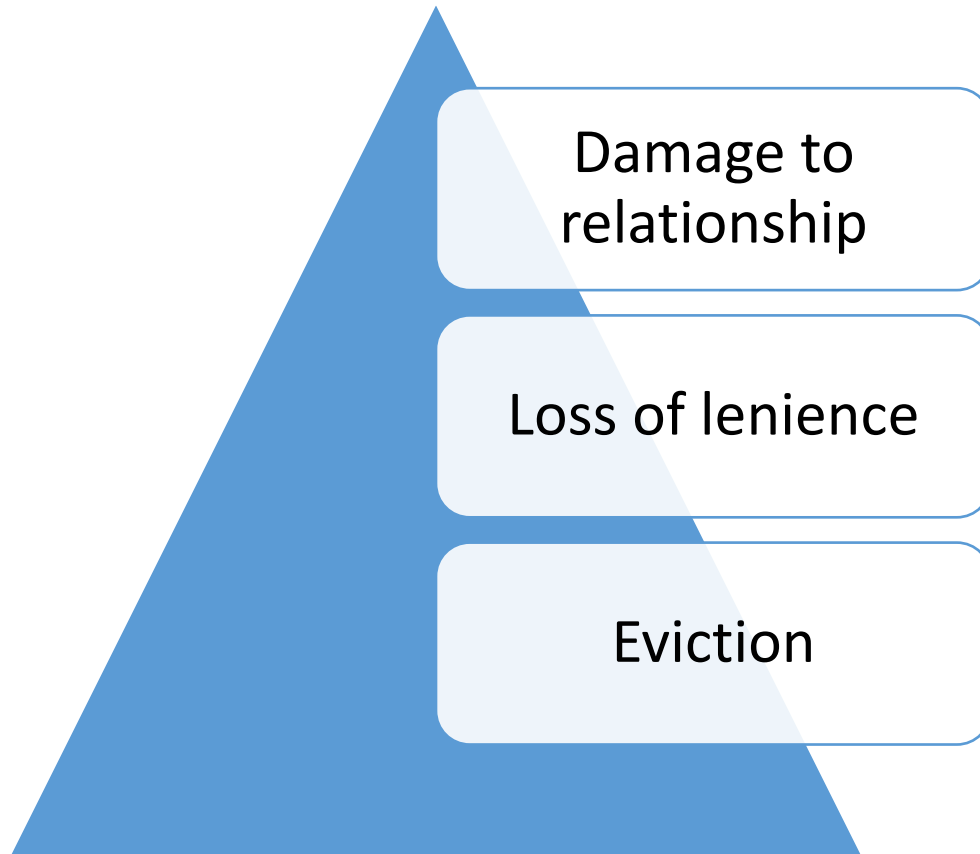

Security of Tenure

You can continue to live in your rental unit until you give your landlord proper notice that you intend to move out, you and your landlord agree that you can move, or your landlord gives you a notice to end your tenancy for a reason allowed by the RTA.

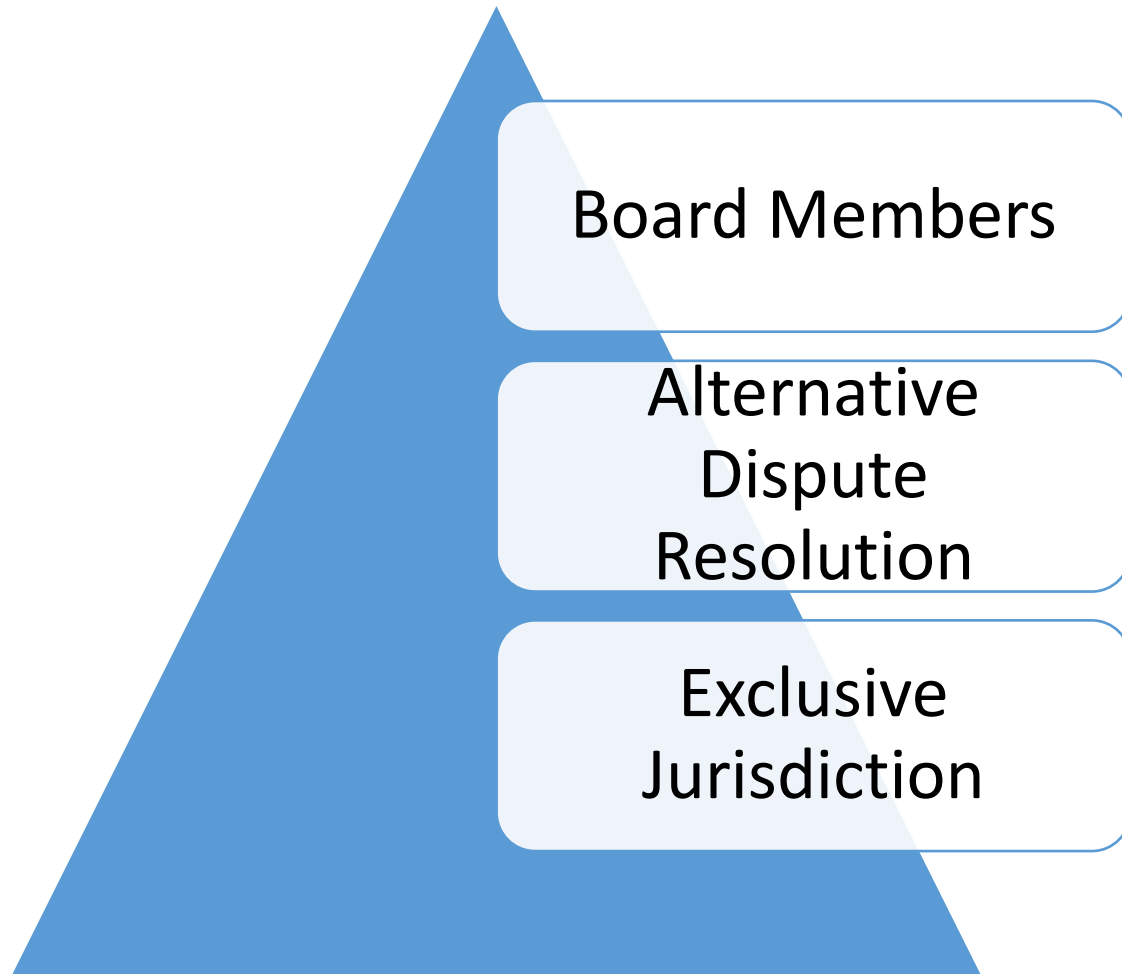

Depending on the issue, there is a specific form you will need to use.

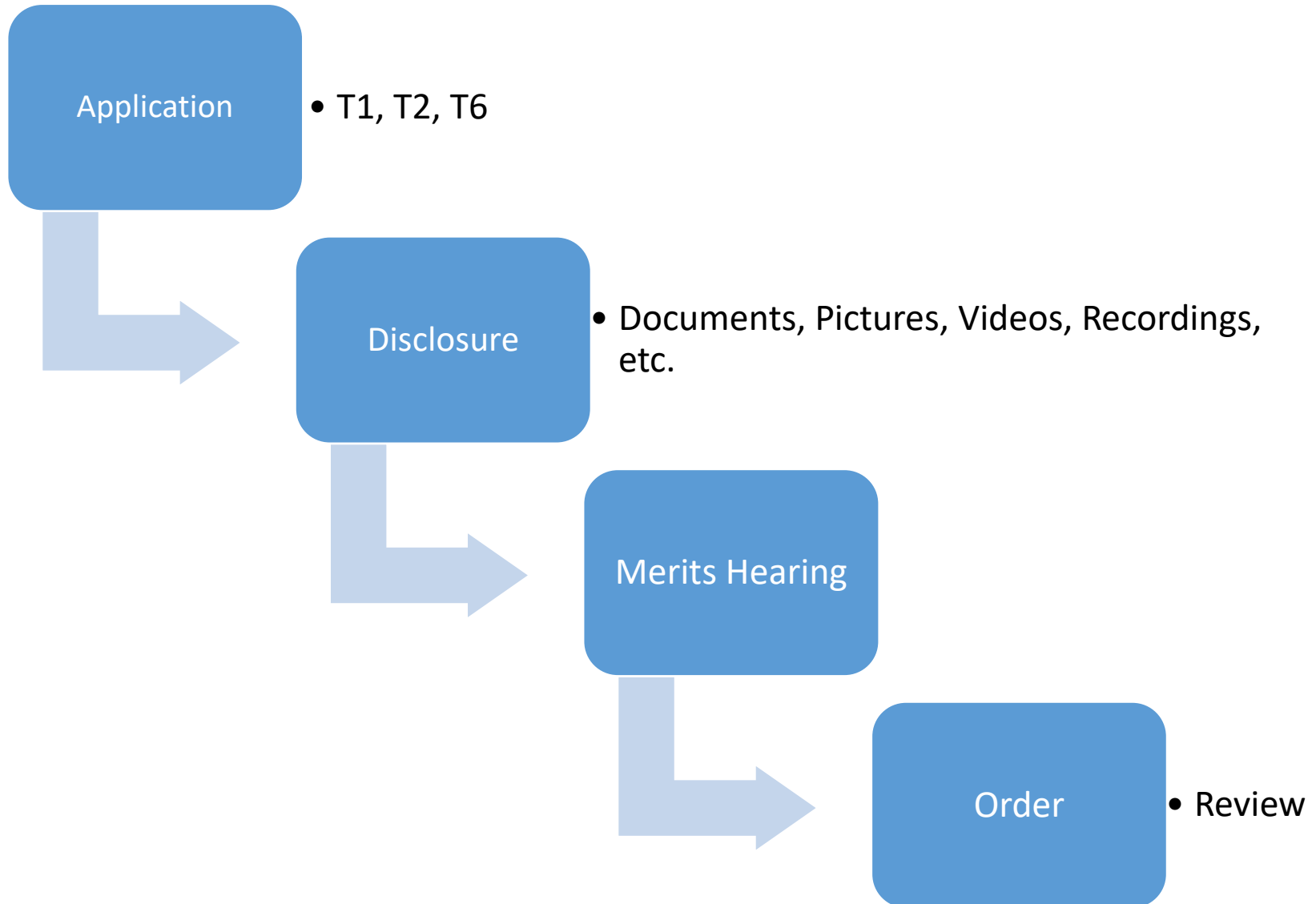

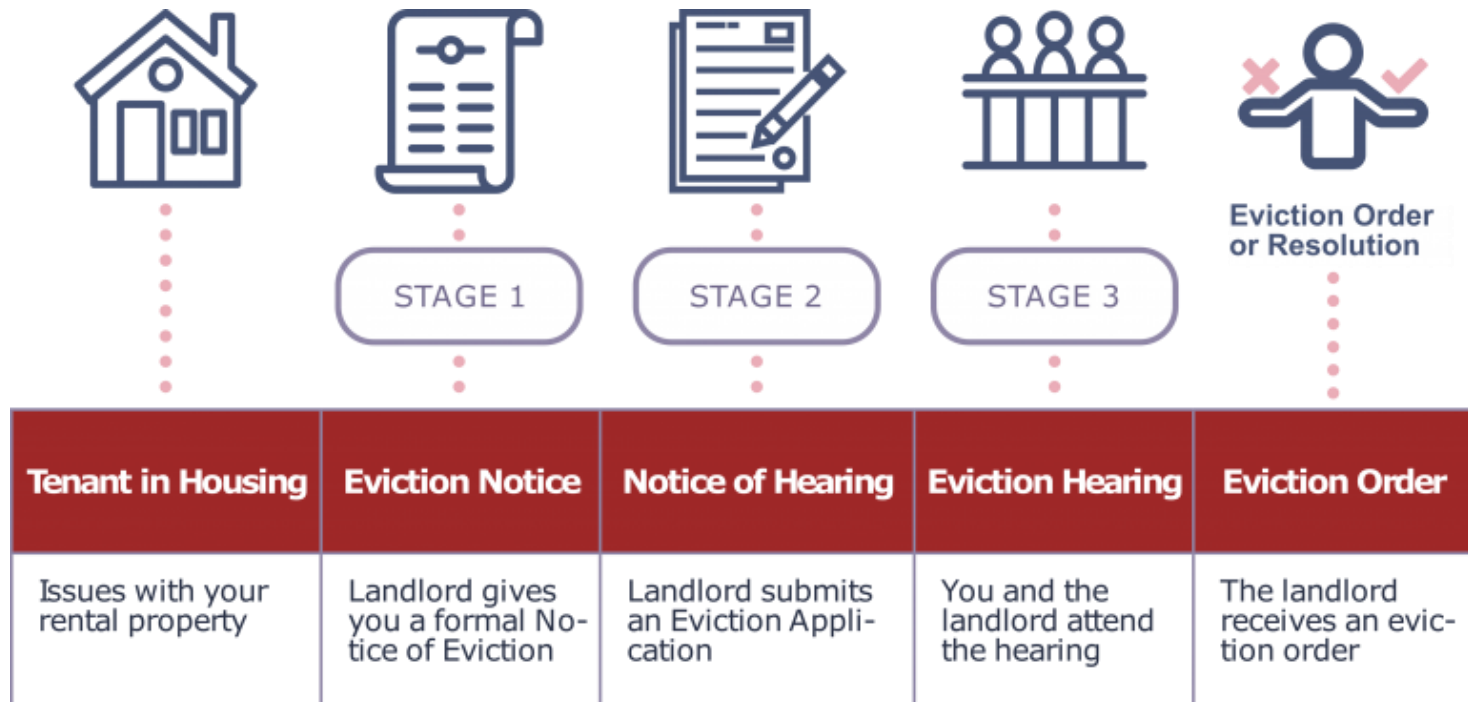
The LTB Process: Tenant Aps.



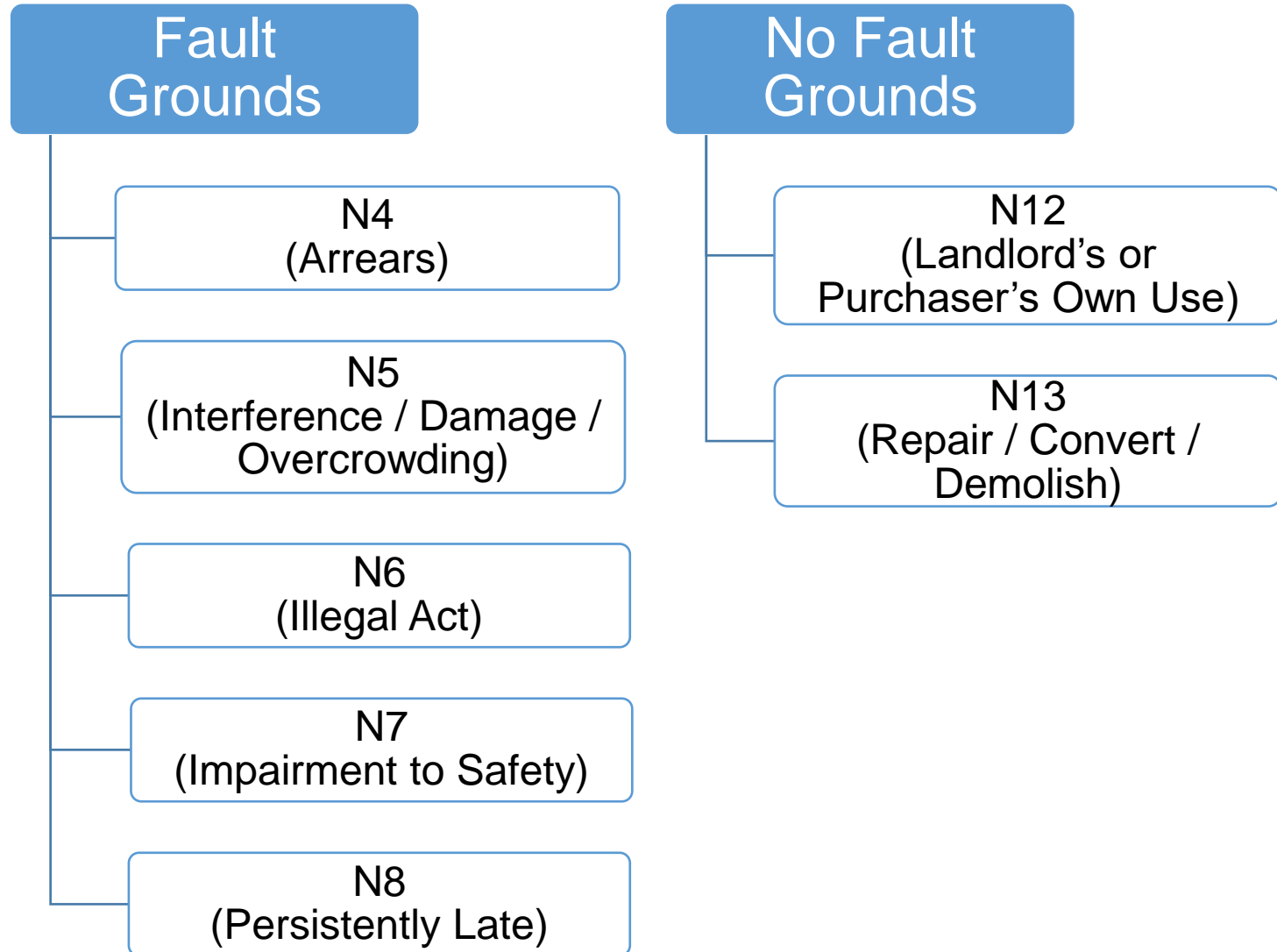
Eviction

Landlords are required to give official notices of eviction which starts the eviction process. A tenant does not have to move out if they receive an eviction notice.

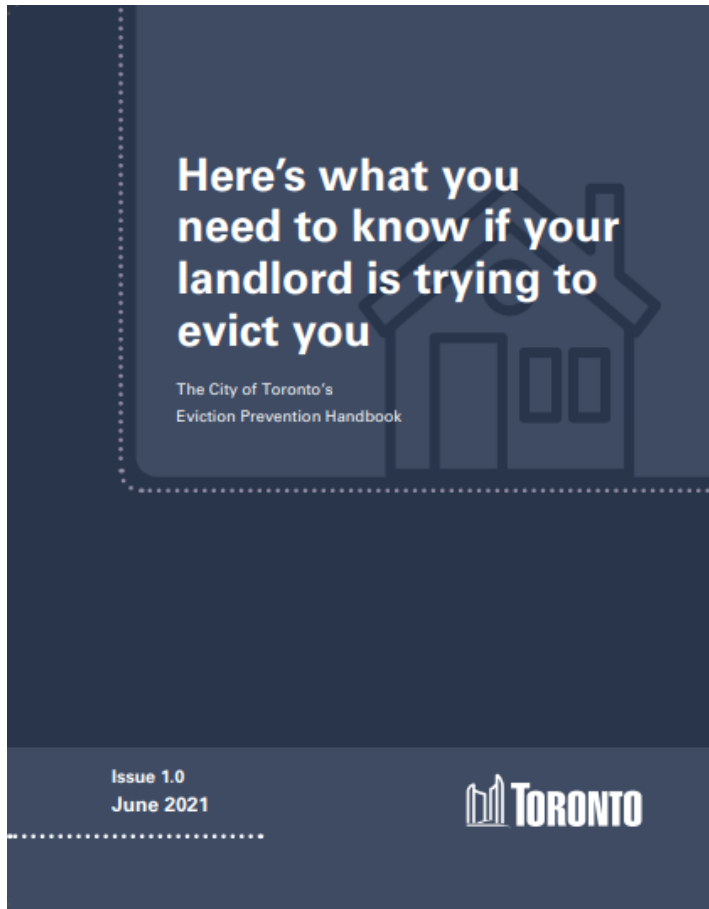
Only if the LTB issues an eviction order, which happens after a hearing, will a tenant need to move out.
