3. Overlea Driveway: Working continuing into the winter on roof replacement above the boiler room.
4. Parking garage lighting retrofit: Date TBC, pending completion of parking garage concrete work.
5. Window washing: 2024 due to building cladding work.
6. Toilet Replacement - Project Completion: Date TBC, but any toilets that were not replaced in the first round will be replaced.
